GENERAL INFORMATION Entrada is a proprietary blend of highly effective, nonionic surfactants and a refined modified spray oil designed for use with pesticides or products whose labels recommend the addition of a spray adjuvant to improve coverage.

The addition of Entrada to a spray tank solution will improve spray application by physically modifying the deposition and wetting characteristics of the spray droplets, which will result in a more uniform spray deposit. However, optimum application and effect can be affected by the pesticide or product, the carrier, crop, pest, type of spray equipment, volume of spray and pressure. droplet size and environmental factor.

DIRECTION FOR USE The addition of a spray adjuvant to some pesticide tank mix combination may cause phytotoxicity to the foliage and or fruit of susceptible crops or plants, therefore prior to use of Entrada in a spray tank mix or application to crops or plants the user or application advisor should perform a test spray under similar environmental and cultural condition to determine phytotoxicity.

# USE: MAY BE APPLIED BY GROUND, AERIAL OR CDA.

GROUND: Use 3 to 5 pints (1.4 to 2.4 Liters) per 100 gallons (380 Liters) of spray solution.

Use 3 to 5 fluid ounces (85 to 140 mLs) in 1 to 5 gallons (4 to 19 Liters) of spray solution.

AERIAL: Use 3 fluid ounces (85 mLs) in 1 to 3 gallons (4 to 12 Liters) and 5 ozs (140 mLs) above 3 gallons (12 Liters).

NOTE: Some pesticide labels may recommend higher or lower rates of spray adjuvant Follow pesticide manufacturer's recommendation.

# MIXING

- Clean all spray mixing and application equipment prior to tank mixing. To prevent or minimize foaming, fill tank 3/4 full of water and add an anti foaming agent to the spray tank before adding pesticide, nutrients or Entrada.
- Add pesticide, nutrients or fertilizer as directed by label or as follows:
   A) Micronutrients and fertilizer B) Dispersible granules or dry flowables
   C) Flowable liquids D) Water soluble pesticides E) Emulsifiable concentrate
- Continue agitation. Add Entrada and mix for 1 to 2 minutes with reduced agitation
- 4) Add balance of water to tank while maintaining agitation.
